Dear Lions Gate Independent Living Community Members,

We hope you are all doing well and staying safe!

As the State begins to lessen restrictions, at Lions Gate, we have started to open up a few areas with much caution. First, we have started in-person programs in Commons Hall, within the parameters for maximum capacity set by the State. Commons Hall was initially sanitized using required products specific for COVID-19, chairs are 6 feet apart and staggered throughout the space and sanitizing stations are located at the entrance for use upon entering and exiting. All residents and program leaders are required to wear masks.

The pool has reopened with certain restrictions: only two residents in the pool area at a time; residents need to reserve a time slot by contacting the Concierge; residents should sanitize their hands before and after using the pool; and masks should not be removed until in the pool area.

Outdoor visiting is now permitted with residents and guests wearing masks, and maintaining social distancing of 6 feet apart. No indoor visits are permitted unless prior approval is obtained from Administration.

The Salon at Lions Gate will be re-opened on Wednesday, July 15th. A separate notice will be sent to residents regarding the protocols for the salon. Please be assured that the Salon will be fully sanitized prior to opening and the stylist will be disinfecting all equipment after each appointment.
