Dear Lions Gate Community Members,

We are pleased to announce that the residents of our Independent Living area will be eligible to receive the COVID vaccination here at Lions Gate. Vaccinations are being provided by the government, through our pharmacy provider Omnicare/CVS. Omnicare/CVS is providing us with the Pfizer vaccine, which is a two-step vaccine, this means the initial dose will be provided on their first visit and the final dose on the second visit. The pharmacy has assigned us the following dates, **01/31/21** and **02/21/21** that they will be onsite to vaccinate. As the date approaches, we will provide instructions and times to residents receiving the vaccine.

You will need to complete the form and provide copies of your medical insurance card. If you are completing this form on behalf of a resident, you must also complete the Consent Form. If your loved one is able to complete the form themselves, you do not need to complete an additional consent form. The form(s) may be completed in 2 ways:

2. We will distribute hard copy forms to all independent living apartments and cottages. Fill it out with a pen, and return it with a copy of the front and back of the medical insurance card to Lions Gate via:

The form(s) must be completed, along with copies of the medical insurance card, and returned by **Wednesday 1/20/21**.

YOU MUST PROVIDE US WITH A COPY OF YOUR MEDICAL INSURANCE CARD – BOTH FRONT AND BACK SIDES. If you do not have the ability to copy the card, please bring the card to the concierge desk and a copy will be made for you. If the resident medical insurance card is not provided, CVS will not provide the vaccine.

Please note the following:

If a resident receives the first dose on 1/31 but is not in the community or is unable to receive the second dose on 2/21 at Lions Gate, it will be the resident's or family's responsibility to determine where to obtain the second dose at an alternate location.

If a resident is out of the community or is unable to receive the first dose on 1/31 – the resident could receive the first dose on 2/21, however it will be the resident's or family's responsibility to determine where to obtain the second dose at an alternate location.
