IMPORTANT VACCINE INFORMATION:

We are prepared for our first scheduled COVID vaccination clinic this coming Sunday, January 10! CVS will be sending 10 vaccinators to visit us from 11am to 5pm, during which time our Skilled Nursing residents, Assisted Living residents and staff members will be vaccinated with the first dose of the two-dose vaccine. CVS will be returning on January 31 to complete the series for those who had the first dose, and to administer the first dose to anyone who missed it on the first visit. We will have one more visit on February 21 to complete the vaccines.

VISITATION INFORMATION

We had received some questions about whether vaccination would allow more liberal visitation rules, but unfortunately, this is not the case at this time. As of today, we have not had any facility-onset cases in 14 days, which would allow us to open to indoor visitation, however, we are prevented from doing so because of the State of NJ being classified as "HIGH" COVID Activity Level. Once this level drops to "MODERATE" OR "LOW", and we have 14 days with no new onset cases, we will be able to open up to indoor visitation. The way to schedule visits remains the same – go to the Lions Gate website at lionsgatecorc.org, click on the red bar "FOR CORONAVIRUS UPDATES", and then click on one of the "Scheduler" buttons to request your visit. Your request is not confirmed until you receive confirmation from our Scheduling Coordinator, Gina Wheeler via email or phone call. Hopefully, this will be able to begin soon. In the meantime, please continue to call our Activity department to schedule your Facetime visits with your loved ones 856-679-2393.

We will continue to provide you with updates as they become available. Please know that we are strictly adhering to and following all infection control protocols and guidance from the CMS, CDC and the NJ Department of Health.
