**Dear Lions Gate Community Members:** 

We hope you had a nice weekend!

We were happy to share that there no new cases of COVID-19 to report. We continue to follow all CDC and NJ DOH recommendations and guidelines. This does <u>not</u> have any impact on visitation. Since we have gone 14 days without a new case of COVID-19, staff members are <u>no longer</u> required to mask. We continue to monitor NJ COVID-19 Activity Level Index (CALI). The CALI is currently "low" for our region.

Please note that Residents who are not up to date with vaccinations (meaning they have not had the bivalent booster) or are not vaccinated, **are still** required to mask at all times while in common areas of the community.

Visitors/Guests may continue to visit with Residents in common areas of the Independent Living are of the Community as long as the County's transmission rate is low to moderate. In addition, visitors/guests are permitted to attend resident programming as long as space permits.

The Bistro is open to Independent Living residents and their guests for breakfast and lunch, Monday-Friday. Residents and guests from Skilled Nursing and Assisted Living **are still not** permitted in the Bistro at this time due to the COVID outbreak. We will inform you when this becomes an available again.

We are currently offering the bivalent booster shot at Lions Gate for all residents and staff members. All residents and staff members are eligible for a bivalent booster as long as it has been four months since the last bivalent booster. The pharmacist is available to come to Lions Gate as needed to administer the vaccine. We are also anticipating that a new COVID booster will be available this fall. When we have more information about this, we will send out an update.
