Dear Lions Gate Community Members:

We hope you are having a good week!

We were informed that 2 Rehab Staff Members, 1 Rehab Resident and 1 Independent Living Resident have tested positive for COVID-19. At this time, we ***strongly recommended that masks be worn in Independent Living by residents and guests while in common areas of the community. Masks are required to be worn by all staff members at Lions Gate. Masks are also required to be worn by residents and visitors in the common areas of Assisted Living, Skilled Nursing and Rehab.*** Guests ***are not*** permitted to attend programming in Independent Living, Assisted Living, Skilled Nursing and Rehab at this time. We continue to follow all CDC and NJ DOH recommendations and guidelines. We continue to monitor NJ COVID-19 Activity Level Index (CALI). **The CALI is currently “medium” for our region.**

Due to the “high” CALI score, visitors/guests **may not** visit with Residents in common areas of the Independent Living of the Community. In addition, visitors/guests are **not permitted** to attend resident programming at this time.

The Bistro is open to Independent Living residents for breakfast and lunch, Monday-Friday. Independent Living guests or residents/guests of Skilled Nursing and Rehab **are not permitted to visit the Bistro at this time.**

The monovalent booster is now available to all Lions Gate residents and staff members. The pharmacist is available to come to Lions Gate as needed to administer the vaccine.
